On SOLO results, eLD copies have an amber/orange circle with the instruction 'Online access is restricted to library computers in any of the Bodleian Libraries'.

Only one person at a time can view each item. There is no time limit set (within a day) for how long an item can be consulted. However, you will be timed out after 5 minutes of inactivity. Once an item has been closed down (or has timed out) it becomes available to another reader.
